MORE THAN \$8.6 MILLION APPROVED FOR FLOOD SURVIVORS

CLINTON, Miss. – Federal assistance approved for people in 14 Mississippi counties that were declared a major disaster area by the president following the historic flooding of the Mississippi River and its tributaries has reached **\$8,670,223**.

While many recovery efforts along the Mississippi River are held back by the heavy flooding, state and federal disaster officials are responding as receding water allows access to flood-damaged areas.

Here is a summary through Wednesday, June 15, of all federal assistance to individuals in counties affected by the flooding that began May 3, and continues:

- **\$7,351,723** in total housing and personal needs has been approved.
- Of that amount, **\$6,917,384** has been approved for housing expenses, including temporary rental assistance, home repair costs and assistance toward replacing destroyed homes.
- **\$434,339** has been approved as “Other Needs Assistance” to cover essential disaster-related needs, such as medical and dental expenses and lost personal possessions.
- **\$1,318,500** in loans to homeowners, renters or business owners has been approved by the U.S. Small Business Administration.
- **3,509** applicants have registered with FEMA for some form of disaster assistance.
- **1,831** visits have been made at Disaster Recovery Centers operated jointly by FEMA and the state of Mississippi.
- **2,436** home inspections to confirm disaster damage have been completed.
- Teams of state and FEMA Community Relations field specialists have distributed more than **27,500 flyers** and worked in the affected counties to help identify and assist disaster survivors. In the course of explaining the recovery process, the teams have visited:

- **1,915** businesses
- **731** faith-based groups
- **203** community organizations
- **51** schools
- **425** emergency managers, fire and law enforcement officials

Several forms of federal assistance may be available, but people must first register with FEMA. That can be done by calling **800-621-FEMA (3362)** or **TTY 800-462-7585**. Telephone registration is available between 7 a.m. and 10 p.m. daily. FEMA will assist anyone with a disability who needs help registering—just ask.

Application can also be made on FEMA's website, www.DisasterAssistance.gov at any time. A person can also track the status of an application on that site. Another way to register is by web-enabled cell phone at **m.fema.gov**.

FEMA's temporary housing assistance and grants for public transportation expenses, medical and dental expenses, and funeral and burial expenses do not require individuals to apply for an SBA loan. However, applicants who receive SBA loan applications must submit them to SBA loan officers to be eligible for assistance that covers personal property, vehicle repair or replacement, and moving and storage expenses.
