MORE THAN \$10.4 MILLION APPROVED FOR SURVIVORS OF MISSISSIPPI'S APRIL STORMS AND TORNADOES

CLINTON, Miss. – More than \$10.4 million in federal assistance has been approved for people in 29 Mississippi counties that were declared a major disaster area by the president because of devastating storms and tornadoes.

Several forms of federal assistance may be available, but people must first register with FEMA. That can be done by calling **800-621-FEMA (3362)** or **TTY 800-462-7585** for people with speech or hearing impairment. Telephone registration is available between 7 a.m. and 10 p.m. daily.

Application can also be made on FEMA's website, www.DisasterAssistance.gov at any time. A person can also track the status of an application on that site. Another way to register is by web-enabled cell phone at **m.fema.gov**.

Here is a summary through Thursday, June 1, of all federal assistance to individuals who suffered losses due to the storms and tornadoes of April 2011:

- **\$6,323,302** in total housing and personal needs has been approved.
- Of that amount, **\$5,262,600** has been approved for housing expenses, including temporary rental assistance, home repair costs and assistance toward replacing destroyed homes.
- **\$1,060,702** has been approved as "Other Needs Assistance" to cover essential disaster-related needs, such as medical and dental expenses and lost personal possessions.
- **\$4,106,700** in loans to homeowners, renters or business owners has been approved by the U.S. Small Business Administration.
- **6,646** applicants have registered with FEMA for some form of disaster assistance.
- **2,692** visits have been made at Disaster Recovery Centers operated jointly by FEMA and the state of Mississippi.
- **4,005** home inspections to confirm disaster damage have been completed.
- Teams of MEMA and FEMA Community Relations field specialists have distributed more than **38,953 flyers** and worked in the affected counties to help identify and assist disaster survivors. In the course of explaining the recovery process, they have visited:
 - **11,673** residents
 - **1,469** businesses
 - **1,058** faith-based groups
 - **194** community organizations

However, applicants who receive SBA loan applications must submit them to SBA loan officers to be eligible for assistance that covers personal property, vehicle repair or replacement, and moving and storage expenses.
